Roster Artist Contract

The Pennsylvania Arts Experience is a non-profit arts organization promoting the arts along the scenic river valleys of southeastern Pennsylvania. We are committed to establishing an internationally recognized arts destination by marketing a membership of creative artists and venues through the Artist Trail, our website, and regional Arts Orientation Centers.

I understand and agree to all of the following:

1. Potential patrons may contact me by phone and/or by email for appointments and I will provide specific directions to my studio. The PA Arts Experience concierge may also make arrangements for studio visits.
2. Not all visitors will be buyers.
3. PAE is an advocate for the Arts/Artists on the trail; therefore the artist receives 100% of on-site studio sales. PAE will receive a commission on work sold at the Arts Orientation Center – Twenty-five percent on original work and fifty percent on prints.
4. I will provide digital images of my work and/or myself to the project coordinators and allow them to be used as needed (e.g. on websites, in printed material, in press releases, in grant requests, on video and on television) to promote the PA Arts Experience. The PA Arts Experience will post a 150-pixel square image, representing a sample of my work, on the artist roster page of the website, along with listing below it my name, preferred medium, and city or town location of my studio. This image will provide a link to a page on the PAE website featuring an additional sample of my work, bio and contact information including a link to my website or gallery site.
5. I agree to be photographed or videotaped as needed for promotional purposes of the PA Arts Experience.
6. Upon request, I will provide to the project coordinator information on studio visits and sales of my work that may or may not occur as a result of my participation in the PA Arts Experience (to be used for the purpose of providing data for grant funding when necessary). Artists name and the clients name will remain anonymous.
7. I agree to answer questions from the project managers designed to evaluate the effectiveness of the PA Arts Exp.
8. The yearly cost of participation as a Roster Contributing Member in the PA Arts Experience is \$100.00. Membership becomes effective upon receipt of payment. *This cost is not refundable.*
9. The PA Arts Experience initiative is a non-profit, contributing membership based, community and grant supported project.
10. The PAE is not responsible for damage and/or liability of any kind that may be caused by visitors. PAE requires that artists allowing studio visits provide a statement of liability insurance coverage.
11. The PA Arts Experience is not responsible for: tax, zoning or other issues related to the sale of artwork in my studio.
12. I will contact the project managers immediately if I decide against further participation in the project.
